### Mark and Paige Telford Receive Regional Hugh Hammond Bennett Award

Mark and Paige Telford of Arco were awarded the regional Hugh Hammond Bennett Award in February. The Telford's were nominated by the Butte Soil and Water Conservation District for their commitment to conservation, civic involvement, soil health practices, and conservation innovation. Growing potato, hay, grain and livestock in Butte County, the Telford's have participated in multiple Natural Resource Conservation Service (NRCS) programs to conserve natural resources on their operation. The Telford's have participated in NRCS special wildlife initiatives and have retrofitted livestock fences to be more wildlife friendly and they rotate their grazing schedule to benefit sage-grouse and other sensitive wildlife. The Telford's have been a leader in soil health practices and implement a five-year crop rotation plan on their potato fields, plant cover crops, and utilize compost. They have also displayed self-driven conservation efforts through participation in research programs to learn more about preventing potato virus Y and

research to conserve water in livestock watering systems. Furthermore, a portion of their potato fields have been USDA certified organic since 2017. Mark has served on the Butte SWCD board of supervisors for nine years and has been instrumental in bringing federal funding into the District to install irrigation efficiency improvement technology on area farms. Mark has been an early adopter of no-till drilling practices and was involved with helping the District purchase a no-till drill to rent to area producers. He has also served 12 years on the Idaho Potato Board's research and education committee. During this time, he advocated for the University of Idaho Extension

Agent position of a Potato Specialist. This position received funding for several years following its inception by the Idaho Potato Commission. The Hugh Hammond Bennett awards are named for the founder of the soil conservation service and acknowledge agricultural producers and professionals for their outstanding efforts to promote and implement natural resource conservation practices. ### Partnership Improves Big Game Migration Route

A recent project in the Big Lost River Valley near Arco showcases how partnerships can be utilized to make a project more successful together than any one agency could have accomplished alone. The Idaho Department of Fish and Game (IDFG) and the Bureau of Land Management (BLM) had previously worked together to retrofit and/or remove fences in the pronghorn migration route near Arco and saw the need to expand the area and work with other agencies and landowners to achieve their conservation goals.

The opportunity came during a local working group meeting hosted by the Butte Soil and Water Conservation District (SWCD). During the local working group meetings, private


landowners and conservation agencies can come to the table and strategize on natural resource concerns in the area. These meetings led to a large-scale project with private landowners and conservation agencies to benefit wildlife along the migration route near Arco.

The IDFG worked with the Natural Resources Conservation Service (NRCS) to provide technical and financial assistance to help private landowners with the retrofit/removal process. The project focused on retrofitting fences to wildlife friendly specifications or removing unneeded fences to

benefit all big game species in the area as well as being visually marked for sage-grouse and other desert birds since the route encapsulates designated core and important sagegrouse habitat. With a \$20,000 grant from the Rocky Mountain Elk Foundation (RMEF) as well as IDFG funds, the IDFG was able to increase the financial assistance for private landowners participating with the NRCS as well as assist landowners who did not have an NRCS contract. Idaho Fish and Game Biologist Habitat Brett Gullet stated that, "The project benefited from partnerships with multiple agencies. The NRCS was able to dedicate program funds as well as use their relationships with the area producers to promote the project." Additionally, the IDFG funded the purchase of a cattleguard (installed gratis by the Butte County Road and Bridge) that allowed the BLM to remove 1.4 miles of fence. In 2023, the Butte SWCD was awarded a \$50,000 grant from the RMEF to increase the cost-share incentive for private landowner fence retrofit/removal projects. In 2022 and 2023, the NRCS worked with private landowners to retrofit and/or remove 110,000 feet of fence, benefitting 9,400 acres.

Furthermore, the US Fish and Wildlife Service donated fence markers that were installed by private landowners and volunteers from the Upper Snake Master Naturalist group to make the fences more visible to wildlife.

The migration route extended onto the Craters of the Moon National Monument (CRMO) where the National Park Service (NPS) was able to work with bordering landowners to retrofit and/or remove fences along the monument's boundaries. In 2023, the NPS partnered with crews from the Utah Conservation Corp to retrofit 7.5 miles of fence to wildlife friendly specifications. National Park Service wildlife biologist Todd Stefanic stated that, "The goals of the project were originally driven by the pronghorn migration and meant to remove barriers to their movement but have since grown to eventually make all CRMO boundary fences wildlife friendly for all wildlife."

### **Conservation Tour Highlights NRCS and WQPA Conservation Projects**

The District's Annual Conservation Tour was held in August and featured conservation projects funded by the Natural Resources Conservation Service (NRCS) and the Idaho Soil and Water Conservation Commission (ISWCC) in the Moore and Arco area. Participants visited Susan Cortazar's seasonal high tunnel installed with NRCS funding in 2018. Susan shared information on the advantages and challenges of gardening in a high tunnel. The group

then visited a newly installed irrigation ditch liner project along the Timbered Dome irrigation canal. Local producers who use the

system along with NRCS Team Lead Jesse Fullmer provided information on the lining process, maintenance, and the water savings provided by the liner. At the next stop, Butte SWCD board member Mark Telford showed a research trial plot along a potato field that is designed to reduce potato virus Y carried by

aphids from entering adjoining fields. The fields are surrounded by a cover crop buffer

that provide aphids a zone to clean their system before entering an adjacent field. The buffer zones were in full bloom and abuzz with pollinators. The tour proceeded to the Nichols' farm to look at irrigation improvement projects partially funded by the ISWCC's Water Quality Program for

Agriculture funds. Derek Nichols was on site to share the history of the farm and how the improvements make the farm more water efficient. As part of the project, a wheel line system was removed and replaced with a center pivot and an open irrigation ditch was converted into pipeline. The project also addresses erosion along a creek bank by the installation of rock rip rap. The tour concluded with lunch provided by the Butte SWCD. We appreciate the landowners who shared their projects with us, to everyone who participated, and to Jesse Fullmer for being an excellent tour guide!

### Weed Spotlight

Scotch thistle, *Onopordum acanthium*, is a noxious weed found in every county of Idaho. The thistle can reach up

to 8 feet tall and disperse thousands of seeds that can survive up to 39 years. The most effective control measure is to spray herbicide on the young rosette before the leaves develop its "hairy" protective covering. Mature plants can be cut down and the sprayed base with herbicide. Flower heads should be removed and placed in a bag for disposal or burning to prevent seeding out after the plant has been cut down. If you have scotch thistle on your property and need help with removal, contact your county weed department.

### 6<sup>th</sup> Grade Natural Resources Tour

September, forty-In three 6<sup>th</sup> grade students from both Butte Middle School and Mackay Elementary gathered at the lower sportsman's access area to participate in a natural workshop sponsored by the Butte Soil and Water Conservation District. The students attended presentations by the Salmon-Challis National Forest. Idaho Department of Fish and Game, Trout Unlimited, Bureau of Land Idaho Management, Rangeland Resources Commission, Natural Resource Conservation Services, South Custer Fire District and Butte County's University of Idaho Extension Office.

### **DEQ Grant Award**

The District was awarded their first Idaho DEQ State Agriculture grant to carry out water quality/quantity best management practices. The \$250,000 award will be utilized to install irrigation pipeline on the Blaine County Canal Company's (BCCC) irrigation system in the Little Lost River Valley near Howe. The funding will allow the BCCC to extend an open irrigation ditch to pipeline project conversion completed already through NRCS an The pipeline contract. system will make more efficient use of irrigation water, allow more water to stay in the Little Lost River, and once the entire system is complete, reduce sedimentation in the river system. The project estimated is to be completed by Fall 2024.

### Jesse Fullmer Named District Conservationist of the Year

Jesse Fullmer was recently awarded the R.N. Irving District Conservationist of the Year Award at the Idaho Association of Soil Conservation District's annual conference in Burley. The Irving Award is named for R. Neil Irving who served as Idaho's first State Conservationist and was instrumental in passing the State Soil Conservation District Law and organizing Idaho's soil conservation districts from 1938-1959. Jesse was nominated by the Butte Soil and Water Conservation District for his achievements in natural resource conservation and going above-and-beyond his daily duties to assist landowners in their conservation goals. Jesse has been with the Natural Resources Conservation Service (NRCS) for 16 years and has been the District Conservationist in the Arco NRCS field office for nine years, covering the Butte SWCD and the Blaine SCD areas.

He and his team manage over 100 landowner conservation contracts and gain around 40 new contracts each year. His office holds 75% of the NRCS easements in the State as well as half of the State's Conservation Stewardship Program contracts.

Landowner's willingness to participate in NRCS programs has been attributed to Jesse's leadership in revamping the conservation district's local working group (LWG) process and encouraging landowner participation. Jesse has worked with the LWG attendees to fund special project initiatives for installing Low Elevation Spray

Application nozzles for pivots in 2018-2019. Jesse has also worked with landowners and Butte County in 2017-2019 to address flooding and erosion issues during heavy runoff years. Furthermore, this past year, Jesse and the LWG attendees drafted a special initiative for retrofitting/removing fences in the pronghorn migration route in the Butte and Blaine conservation districts to make them more wildlife friendly. His leadership in working with partner agencies brought USFWS and Idaho Fish and Game monies and guidance to bolster this project even further and was very successful.

Additionally, Jesse worked to bring joint chiefs funding into his coverage area and will be working with the Forest Service to complete this project in the Blaine SCD.

The Butte SWCD board of director's listed Jesse's extraordinary contributions to our conservation district and "going the extra mile" as his work on irrigation efficiency improvement projects in our District. Jesse has worked with the Big Lost River Irrigation District to bring them to the table as a partner in these projects. Irrigation board chairman Byron Pehrson stated, "Jesse is always willing to help people and will bend over backwards to help. He will do what it takes to get the job done."

Jesse and his team brought the first Bureau of Reclamation WaterSmart monies into Butte County in 2019 to complete the County's first ditch-to-pipeline conversion project. Jesse has worked with groups of landowners to create organized water entities to help them address their irrigation improvement needs.

Jesse attends every conservation district board meeting and participates in District events such as the annual 6<sup>th</sup> grade natural resources tour and Envirothon. Butte SWCD Board Chairman Randy Purser stated, "Jesse has been an asset to our District's landowners. The technical assistance he provides to help producers reach their conservation goals is solid. He has also been able to bring in additional NRCS funding when it was needed for special projects and natural disasters."

Furthermore, Jesse goes above-and-beyond by serving on committees such as the NRCS civil rights committee. NRCS State Conservationist Curtis Elke stated, "Jesse serves as the Idaho NRCS Civil Rights Chairman making sure all our customers are treated equally, fairly and have access to all our programs. Also equal employment opportunities for all our staff, assuring we have a great working environment for all our staff. Under Jesse's leadership, the Civil Rights Committee developed an interview guidance document for all NRCS Idaho hiring officials making sure we are interviewing all applicants in a consistent and ethical manner. I sure enjoy working with Jesse and the passion he demonstrates in all he does every day."

The Butte SWCD turns 70 years old this year. Incorporated in 1953, the SWCD has provided a





Map generated by the NRCS




